Serious exposures to Iodine are seldom encountered in industry due to the low volatility of the solid at room temperatures. Will stain skin. **CHRONIC EFFECTS / CARCINOGENICITY:** Chronic ingestion of large amounts may result in thyroid disease.

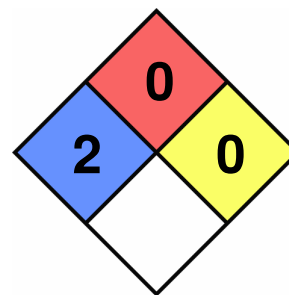
