### 4.2. Most Important Symptoms and Effects, Acute and Delayed

Will stain skin. **CHRONIC EFFECTS / CARCINOGENICITY:** Chronic ingestion of large amounts may result in thyroid disease.

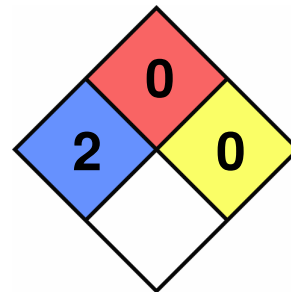
