4.2. Most Important Symptoms and Effects, Acute and Delayed

Causes severe skin burns and eye damage. Causes serious eye irritation. Hazards increase as concentration increases. Most assume that solutions of Silver Nitrate do not reach hazardous concentrations until approximately 5%. Will temporarily discolor skin. Wash areas of contact with water. May be fatal if swallowed. Can cause sore throat, vomiting, and diarrhea. EYE CONTACT: May cause irritation, redness, pain, and tearing. SKIN CONTACT: May cause irritation and temporary discoloration of skin. CHRONIC EFFECTS / CARCINOGENICITY: Chronic exposure can cause permanent bluish discoloration of the skin.

4.3. Medical Attention or Special Treatment Needed

Immediately call a POISON CENTER or physician. Specific treatment (Wash areas of contact with water). Irrigate immediately with large quantity of water for at least 15 minutes. 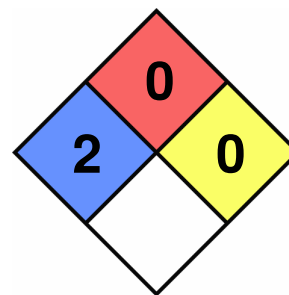
