SKIN CONTACT: May cause irritation. Will stain skin. CHRONIC EFFECTS / CARCINOGENICITY: Chronic ingestion of large amounts may result in thyroid disease.

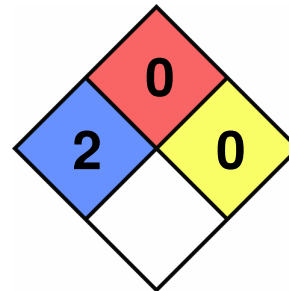
