4.2. Most Important Symptoms and Effects, Acute and Delayed

Serious exposures to Iodine are seldom encountered in industry due to the low volatility of the solid at room temperatures. Will stain skin. Wash areas of contact with plenty of water. For eyes, get medical attention. **EYE CONTACT:** Causes irritation. **SKIN CONTACT:** May cause irritation. Will stain skin. **CHRONIC EFFECTS / CARCINOGENICITY:** Chronic ingestion of large amounts may result in thyroid disease.

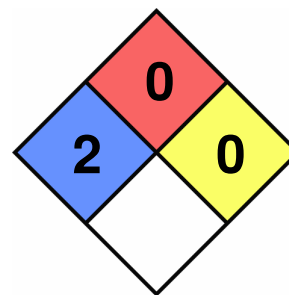
