If swallowed, do not induce vomiting. Give large quantity of water and call a physician. Wash areas of contact with plenty of water for 15 minutes. For eyes, get medical attention. EYE CONTACT: Causes severe irritation, redness, pain, tearing and burns. SKIN CONTACT: May cause irritation, redness, and pain. 
