

# **DEA Registration Requirements**

The Drug Enforcement Agency (DEA) enacted the Domestic Chemical Diversion Control Act of 1993 and the Chemical Diversion and Trafficking Act of 1988 to control chemicals that can be used in the clandestine production of controlled substances. DEA has classified these regulated chemicals as List I and List II and has the authority to modify the lists at any time. Effective August 1, 2007, DEA moved Iodine from a List II to a List I chemical. Refer to <a href="https://www.deadiversion.usdoj.gov/">https://www.deadiversion.usdoj.gov/</a> for more information.

The following information is given to assist our customers in complying with the DEA regulations.

### DEA REGISTRATION REQUIREMENTS FOR LIST I CHEMICALS

- DEA registration is required if you are going to purchase the product for resale.
  - Based on business activity (manufacturing, distribution, importing and/or exporting)
    - Separate DEA registration required for each activity and each location.
  - Ricca Chemical Company must have a copy of your current registration on file prior to sale.
- DEA registration is NOT required if you are going to purchase the product for internal use.
  - Ricca Chemical Company must have an intended use letter on file for those not required to register before the order will be processed.
  - The intended use letter MUST be updated annually.
- DEA registration and fee payment are an annual requirement.

#### DEA REQUIREMENTS FOR LIST II CHEMICALS

• DEA registration is NOT required.

### DEA REQUIREMENTS FOR LIST I AND LIST II CHEMICALS

- Ricca Chemical Company must obtain and maintain, on an annual basis, a list of the names and signatures of the authorized buyers for regulated transactions of DEA restricted chemicals prior to sale.
- Keep records of the buyer to verify the existence and validity of the business entity.
- Keep records of the purchase date, quantity, and method of transfer
- Report to DEA suspicious purchases and/or unusual or excessive losses of the listed chemicals
- Quantities may be restricted per order.
