4.2. Most Important Symptoms and Effects, Acute and Delayed

Causes damage to organs through prolonged or repeated exposure. Does not present any significant health hazards. Stronger concentrations of Iodine solutions are used as topical solutions. Serious exposures to Iodine are seldom encountered in industry due to the low volatility of the solid at room temperatures. Wash areas of contact with water. **EYE CONTACT:** Causes irritation. **SKIN CONTACT:** May cause irritation. Will stain skin. **CHRONIC EFFECTS / CARCINOGENICITY:** Chronic ingestion of large amounts may result in thyroid disease.
