SECTION 4: First-Aid Measures

4.1. General First Aid Information

4.3. Medical Attention or Special Treatment Needed

If breathing is difficult, give oxygen. Wash areas of contact with soap and water for at least 15 minutes. Call a physician if irritation develops. Dilute immediately with water or milk.
