SECTION 4: First-Aid Measures

4.1. General First Aid Information

Eye Contact: IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. May cause irritation with burning and stinging with possible damage to the cornea and conjunctiva.

4.2. Most Important Symptoms and Effects, Acute and Delayed

Causes serious eye irritation. Flammable liquid. Harmful if swallowed or inhaled. If ingested, vomiting may occur spontaneously, but do not induce. Call a physician immediately. Causes irritation to the eyes, skin and respiratory tract. Wash areas of contact with water. May affect central nervous system. **EYE CONTACT:** May cause irritation with burning and stinging with possible damage to the cornea and conjunctiva. **SKIN CONTACT:** Results in drying and cracking which can lead to secondary infections and dermatitis. **CHRONIC EFFECTS / CARCINOGENICITY:** Prolonged or repeated exposure may cause dermatitis.

4.3. Medical Attention or Special Treatment Needed

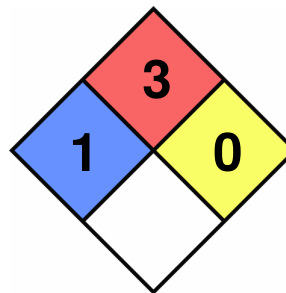
