## SECTION 4: First-Aid Measures

### 4.1. General First Aid Information

### 4.2. Most Important Symptoms and Effects, Acute and Delayed

Toxic if swallowed. Harmful in contact with skin. Causes serious eye irritation. Toxic if inhaled. Flammable liquid. May be fatal if swallowed, inhaled or absorbed through the skin. Forms Cyanide in the body. If ingested, give large quantity of water and induce vomiting. Call a physician immediately.

Contact may cause irritation to the skin, eyes and respiratory tract. Wash areas of contact with water. It is excreted in the urine as Cyanide.

Acetonitrile metabolizes into Cyanide over 2 to 8 hours, so symptoms or signs of toxicity may be delayed after significant exposure. EYE CONTACT:

May cause irritation with burning and stinging with possible damage to the cornea and conjunctiva. SKIN CONTACT: May result in irritating rash.

May be absorbed through the skin with effects similar to those of inhalation. CHRONIC EFFECTS / CARCINOGENICITY: Long-term exposures may affect liver, kidneys and central nervous system.

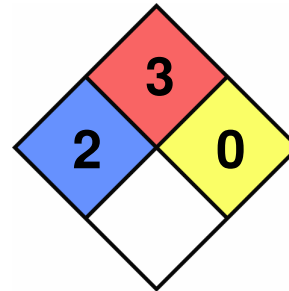
